#### **About the Award**

The Indian Merchants' Chamber (IMC) Inclusive Innovation Award, 2012 will recognize product or service innovations which are inclusive, capable of commercial exploitation, sustainable and scalable.

Inclusive means "more from less for more and more people". It means making products or providing services at very low cost using minimal of raw materials, time and other resources so as to make them affordable for large sections of the society.

The innovation must, therefore, be such that it is highly cost effective and affordable; makes a difference to the lives of many – touching masses.

The aim and objective of the Award is to recognize the contribution of such inclusive innovators, provide them mentoring support and to link them with entrepreneurs.

### Eligibility Criteria for participation in the Award

- Participant can be any person of Indian Origin including:
  - ✓ Individual
  - ✓ Public Sector Enterprise

- ✓ Government
- ✓ Private Sector Enterprise
- ✓ Academic/ Research Institution
- ✓ NGO/ Trust
- The product or service capable of commercial exploitation and scalability will be considered for the Awards.
- The product or service could be under development, developed or could even be in the market. Incase the product or service is in the market, same should not have been commercially launched before Jan 1, 2012.
- Product or service development which are at the stage or level where it can be commercialized and/or scaled up will be given preference.

# **Evaluation parameters**

- All innovations are eligible including:
  - ✓ Technology Innovation
  - ✓ Business Process Innovation
  - ✓ Workflow Innovation
  - ✓ Organizational Innovation
- Evaluation of the entry will be done on the following criteria
  - ✓ Innovation of the product / service
  - ✓ Impact on the society at large.
  - ✓ Sustainability of the product / service
  - ✓ Affordability of the product / service

#### **Timelines**

• The Awards will follow the following timelines:

# Receipt of Entries

- Receipt of entries after last date of receipt specified may be permitted only at the discretion of the Awards Management
- Awards Management will not be responsible for application forms that are lost in transit / received late
- Entry for the Award, in the specified format, giving requisite information/data in support of the entry, may be downloaded or submitted online (<a href="www.imcnet.org">www.imcnet.org</a>). The entry may also be emailed in the requisite format to <a href="mailto:ininawards@imcnet.org">ininawards@imcnet.org</a>).
- If Applicant desires to send the entry in hard copy, that should be submitted to IMC's Office at Churchgate, Mumbai, on or before the last date for submission, in an envelope marked " IMC Inclusive Innovation Award, 2012".

# Completeness of Entries/ Disqualification

- The Application Form needs to be completed and signed by the individual submitting the application and in case of application by an organization, it must be signed by senior officer of the organization (from amongst the MD, CEO, COO, CFO, Chairman, Directors, Partner, Trustee, etc.)
- Incomplete Application Forms received through any mode will disqualify the Applicant from participating in the Awards
- Entries will be accepted in English only
- Disqualification of entries received is at the sole discretion of Awards Management, on a case by case basis

#### Information

- If at any time, any information provided by any Applicant is found to be incorrect in any manner, then the Applicant will not be permitted to continue participation in the Awards.
- If after the conclusion of the Award ceremony, any information provided by any Applicant is found to be incorrect in any manner, then the Applicant will be liable to return the prize / prize money provided to the Applicant under this Award, if any.
- Determination of whether information is incorrect or not rests with Awards Management.
- Awards Management has the right to ask for proof of information provided / audit the
  information provided in the Application Form. If such a request is made and the Applicant does
  not comply, the Applicant could be disqualified from participation at the Awards.
- Awards Management reserves the right to make the final judgement in case of any ambiguity in Rules and Regulations / disputes over suitability.

# Verification of the information provided in the Application Form

- Awards Management will contact the Applicant, if required, for any clarifications needed for the information provided in the Application Form.
- Awards Management will make the best efforts possible to contact the Applicant, but shall not be responsible if the person does not participate in or does not agree to the conduct of the verification, or are not contactable.

• In the event of it not being possible to conduct a verification of the Applicant, for any reason beyond its control, Awards Management may, at its discretion, disqualify participation or continue in such other manner as deemed fit.

## Short-listing upto 5 nominees from applications received

- Applicants understand and agree that mere participation in the Awards does not entitle Applicants to win a prize.
- The Jury may decide, in order to maintain high standards of these awards, not to give Award to any Participant.
- Jury will short list upto 5 Nominees for further consideration.
- The decision of the above short-listing is binding and final on all Applicants.

#### **Determination of Winners**

- Top 5 nominees will be requested to come to Mumbai for Question and Answer (Q&A) session
  with the Jury. The cost of travel, stay and all other incidental costs will have to be borne by the
  nominee. The Award Management may, in deserving cases, decide to bear some or whole of
  the cost of travel and stay of the nominee, at its discretion and the same will not be open to
  discussion.
- The Jury will score / rank the Nominees based on the Application Form submitted by them and question and answer session
- The Jury's decision is final and binding on all Nominees.

### Award for the Winner

- Jury will select one Award Winner who will be given financial support of Rs 20 Lakhs in a form that is considered appropriate by the Jury, which could include initial seed capital.
- Each of the other short listed Nominees will be presented Certificate of Appreciation/Recognition or any other form of recognition as considered appropriate by the Jury.
- The Award Winner will also be provided mentoring support to take the innovation to the market or, if the product or service is already in the market, to enhance its scale/level.

### General

- Decision of Awards Management on all matters is final and binding on all Applicants and Nominees and no correspondence will be entertained on the same
- Nominees and Winners permit free of cost the use of their name and factual information about their application and entry(s) in the public media (for the build-up to the Awards, during the Awards ceremony, etc) and do not have any right to any revenues earned through intellectual property rights generated by the Awards, if any
- IMC and KPMG will not be liable for any claims / disputes made by the Applicant or Nominee in relation to the Awards
- The Awards Management cannot and shall not be accountable / liable for any disruptions / stoppages / interruptions or cancellation of the Awards. IMC, its associates, sub-service
